At 10:30 am, the meeting opened with the Serenity Prayer in SLT, CA Wallace read the Traditions – Danny read the 12 Concepts Prior to beginning business, Karen asked if the minutes from January-February 2017 had been approved before her arrival (she was late to the meeting), as it was not in the notes that were taken. They were not, so that was the first order of business. They were approved unanimously. Minutes from May-June approved unanimously approved.

1. Phoneline balance is \$992.60. All areas are current and payments are being received regularly. AT&T has increased their rates again.
2. Next convention meeting is June 23, 2017 at Round Table Pizza (4<sup>th</sup> and Vine) in Reno at 2:00 pm, Karen reports the 2018 contract has been signed and counter-signed. There is an increase from \$1500 per day to \$2000 per day for Friday and Saturday (no fee for Thursday or Sunday). The resort fee will increase from \$10 this year to \$20 in 2018. Karen was able to negotiate the resort fee from \$25 to \$20 for 2018. She asks that all members refrain from negativity when speaking about booking rooms and rather mention that other states charge large parking fees and Wi-Fi charges and that Reno is just coming into line with other states.
3. Gratitude Dinner: An email from Misty states that they will have their first meeting, a breakfast meeting, on July 15, 2017 at 9:00 am at their home at 3966 Center Drive, Carson City.
4. Treasurer – RSO general account - \$16,833.74 of which \$992.60 are phoneline funds. Insurance was paid. Liability - \$2851 and D & O - \$1609 There were two requests for riders. One for Carson City for Summer Fun Days at Mills Park and one for the softball game in Sparks for the convention. Deposits of \$40 for the Carson City rider and \$80 from WSZF for the AD's unused per diem were made. Convention account has \$14,453.57 and RSC has \$8724.17
5. Curt brings up some issues with the website. The lack of a convention flier and a broken "Home" page link. Karen tells Curt that there is no flier ready (the brochure arrived at RSC and Karen will send to the website for uploading) and we will ask Walter about the broken link at RSC

## Sierra Sage Region NA Behind The Walls Sponsorship Program

Hello Sierra Sage Members:

July 9, 2017

1. I am so happy to report that The Behind the Walls Sponsorship Program has had the best month of its ENTIRE History. After sending out our annual facility packages this year, just 90 days ago to the Florence McClure Women's Correctional Center, we have made a difference to the Asst Warden of Programs, the Stars Program Managers, and women inmates themselves. In the Month of June 2017, we received 82 requests for our program Packets within 30 days. All from Women!! This has never happened before and it is a new Sub-Committee record! In the first week of July we have received 23 letters. We need more NA Member/Sponsor participation. I will be recruiting as much as humanly possible. We have a short waiting list. I predict it will be longer for the women very soon. Currently 2 women and 6 men.

2. The new PO BOX in Reno is now up and running. The influx was a day turnover which caused a small ripple, a few returns but new flyers with address changes have been sent out by this SubCommittee. We have a 6 month forward in and we will renew the forward in November when the PO Box payment is due again.

3. We are a bit over our budget (\$17.02) due to the Washoe County PO Box charge (\$90) being \$26 more annually than Lyon County (\$64) and the postage costs this month were more than our average. (See attached spreadsheet)

4. Proud to announce Abby Berhorst has officially been voted our new Vice Chair. Welcome Abby!!! :D

5. We are presenting 4 Motions on the table this Regional meeting:

A. We are Motioning for 2 increases in our budget:

1. a \$90.00 increase in our annual budget re: the PO Box ( $\$90 - \$64 = \$26$ ) ; (if the Regional Treasurer prefers to pay it by check, that's fine too, whatever this group decides.) It was always paid by Region, before for H&I, but now it is budgeted to BTWSP with a 26\$ increase in cost.

2. Also, a 20\$ increase quarterly due to the growth increase to cover postage/ink/paper now that we are up and running in the Women's Prison. (Breakdown:  $\$155.00 + \$22.50$  (PO Box Qtrly) =  $\$177.50 \times 4$  / (Old Budget  $\$580 / \$540$  vs New Budget  $\$710$ ) =  $+\$106.00$  increase (Plus  $\$94.00$  PO Box)

- B. We are Motioning for \$500.00 each for our Chair (Sheryl) and our Vice Chair (Abby) to be able to attend Western Service Learning Days in Monterey California in October this year. The amount for our Vice Chair might be less, as Rural Nevada Area is trying to be able to supplement her attendance financially. We need to register and get our rooms as soon as possible and figure our budget costs. Some Members are already registered with rooms booked.
- C. Motion to receive our Quarterly Subcommittee Budget of \$155.00 (We are no longer paying for the printer, it is paid off, so it was calculated at \$10 less + the 20 increase).

Several new meetings have been added to BLAW and members have been disappointed they have not been added to the meeting list based on social media mention. Members were informed that there is a request form on website to add/edit meetings. Otherwise a homegroup member or Area can notify that meeting needs to be added. Member stated that meeting may not want to join an Area. Webservant referred meetings wishing to exercise this autonomy to SSRNA Outreach per Regional guidelines as well as reminding member that many meeting waited 3-6 months to judge viability before moving to add to meeting list. BLAW has agreed to send additional funding (\$500) to support the Delegate Team to attend Western Service Learning Days \$250 last month and \$250 this month hopefully other Areas will see what they can do also.

Two events were successful "The Prom" and "4<sup>th</sup> of July Freedom from addiction which had an attendance in excess of 250 addicts as we literally ran out of plates (not food)

Public Relations needs support as does H&I we are sending people to Susanville and I have applications for all interested Addicts.

The Good Fellas are hosting the BLAW Championship, "The Recoverython" flyers are available and any Area is welcome to come the event is Sunday September 3<sup>rd</sup>, in Fallon.

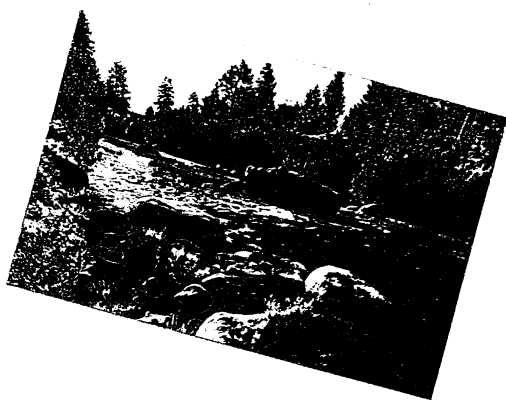

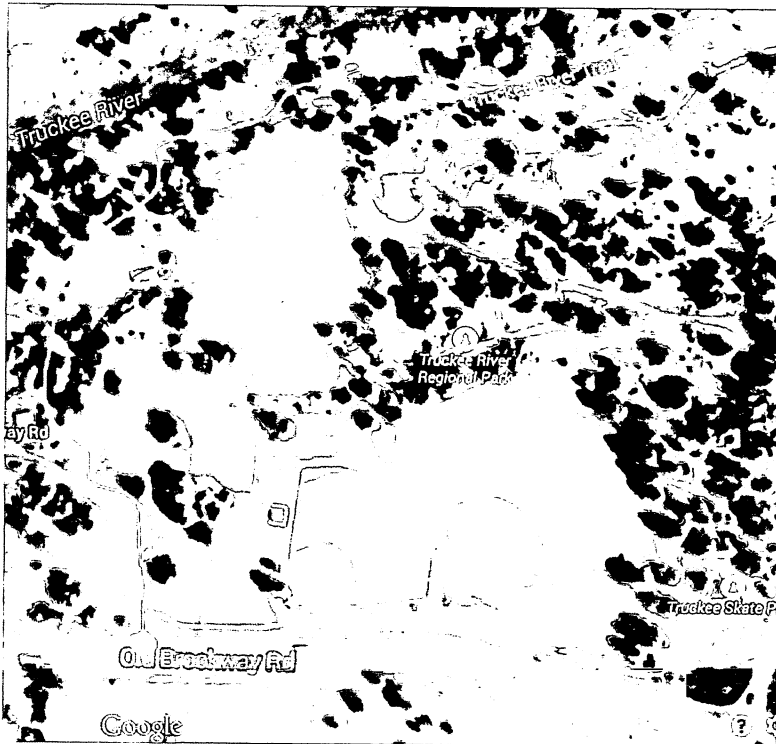
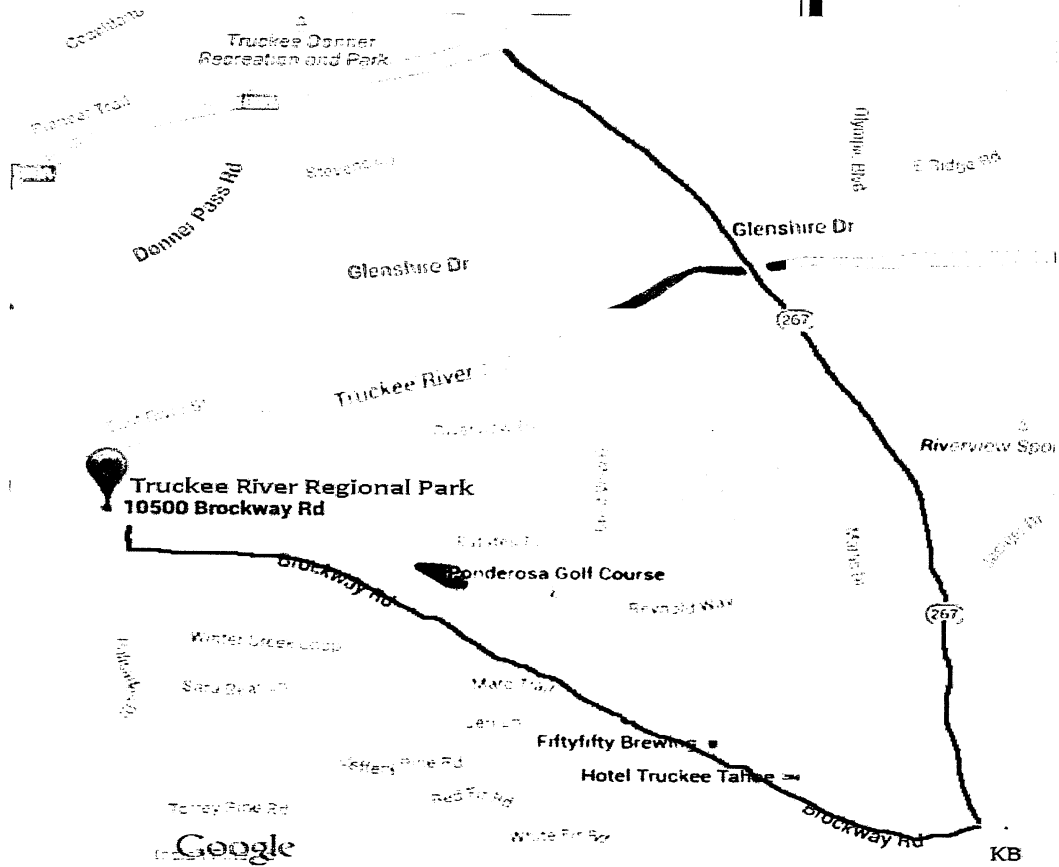
