At 11:02, Jimmy G opened the meeting with the Serenity Prayer in Carson City, NV. Curt read the Traditions – Mark read the 12 Concepts Minutes from September/October approved unanimously.

- 1. Phoneline balance is \$790.08. All areas are current and payments are being received regularly.
- 2. Next convention meeting is November 19, 2017 at Round Table Pizza (4<sup>th</sup> and Vine) in Reno at 11:00 am. Michelle (VC1) was in attendance and reported that the convention went well. There was approximately 200 250 registration bags left over. There was a feeling that the weather may have been the cause; however, there were 1200 registration packets purchased rather than 1000. Merchandise went well, but there were many of the yellow T-shirts and tank tops left over. There was an email complaint by a member who had an issue with the way their shirt looked after washing. (There was a comment from one of our members that it looked as though it had been washed and perhaps left in the washer for too long wrinkled and kind of wadded up). Curt would like to see some "tall" sized shirts again at future conventions. There was an issue with Marathon's being unmanned during part of the late night hours. There are no numbers in for Michelle as of yet.
- 3. Gratitude Dinner: Max gave the report as Misty and Donelle was not in attendance. There will be the usual potato-peeling party on Friday! The committee is asking that all areas provide raffle baskets and all should try to bring a side dish. November 18, 2017 at Fuji Park in Carson City, beginning at noon with dinner at 2 pm.
- 4. Treasurer RSO general account \$15,184.22 of which \$790.08 are phoneline funds. Karen has provided an insurance certificate for a Bishop facility. \$700 was sent to Donelle for the Gratitude Diner (\$200 of which was contributed by BLAW). \$740 paid to Carson City Parks & Rec for Fuji Park, and \$132 was paid to USPS for PO Box 7324 for the year. Convention account has \$44,155.35. Karen doesn't have the final breakdown and hasn't been able to get the information from the convention treasurer for the cash deposits from the convention yet. She should be able to a final report in January. RSC has \$8266.96.
- 5. Curt brings up the area motion at BLAW to sell literature outside of ASC and this is a lead in for his request to investigate the creation of a physical RSO. A lengthy discussion ensues with many pro and cons where, would be used, etc. There is no opposition to the creation of an ad-hoc committee to begin this research. There are many logistical needs to be addressed such as insurance, rent, special workers, inventory..... Curt will spearhead this ad-hoc committee.
- 6. Elections James asks Jimmy if he is willing to continue as chair for another year. Jimmy states that he is willing but he and Lisa may be moving. This is acceptable to all. James then states that he would like the executive body to remain that same. There is no opposition and the body will be: Jim G-Chair, James C-Vice Chair, and Karen R Secretary/Treasurer
- 7. Abbey asks that Sheryl Miller be accepted as a board member. She has been in attendance at the past several meetings. No questions, no opposition. Welcome, Sheryl!!!

## REGIONAL DELIGATE REPORT

Thank you for the opportunity to go to WSLD 31 in Monterey. Because of the fires in California the California Collaboration was cancelled. I had the opportunity to focus on the learning days and soak up some mentorship on how to better perform my service position as well as provide insight; background and more well rounded solutions for members of this region. I went to the regional delegate round table. The discussion was about the zonal system as inevitability for the U.S. The discussion was more about HOW it would work here not IF it would work here. Facebook was seen as a double edged sword and was extremely helpful in getting announcements out however it was viewed as highly negative when it came to discussions and needed to be monitored by a member who had a firm grasp of traditions closely.

## REGIONAL H & I NEEDS YOUR HELP

We are presently working on building what will become a sustainable H&I service for our Area's servicing NVDOC (prison's) facilities with in Sierra Sage Region. We are presently servicing, Ely state prison, Lovelock correctional ctr, Northern Nevada Correctional Ctr, Warm Springs, Stewart Camp, with either literature or Addicts cleared as volunteers doing H&I service in these facilities. Our goal here is to make these services functional/attractive inside our fellowship as well as to NVDOC.

We are hoping to find some other people that would like to help nurture and grow our H&I services here in Sierra Sage. Other positions that could help our H & I efforts would be:

- 1) Helping coordinate people getting cleared/staying cleared/in service.
- 2) Literature distribution to facilities.
- 3) PR/Communications with DOC and other facilities as we are able.

I'm planning to stay and work directly with NVDOC administration, developing our relationship with the state facilities within NVDOC, both women and men. The women's side is a little more challenging due to the geographical locations of these facilities. There are women in many of our area's within our Region that are interested, but the locations of these facilities make them a little reluctant to get involved due to travel. Developing an NA program that will help them thru the mail and/or develop a meeting with in their facility is possible and available. Here are a few:

- 3) A NEW WAY TO LIVE, is a program conceived to help facilities develop their own NA meetings within their facilities without outside sponsors.
- 4) REACHING OUT, is a quarterly H & I publication that our region/area's are using now.

Communicating this information thru Administration is key at this point so they know we have services available for them.

Meeting attendance has been better than average. We still have one meeting every day of the week, for in Truckee, and 3 and Kings Beach. The meeting schedule has not changed.

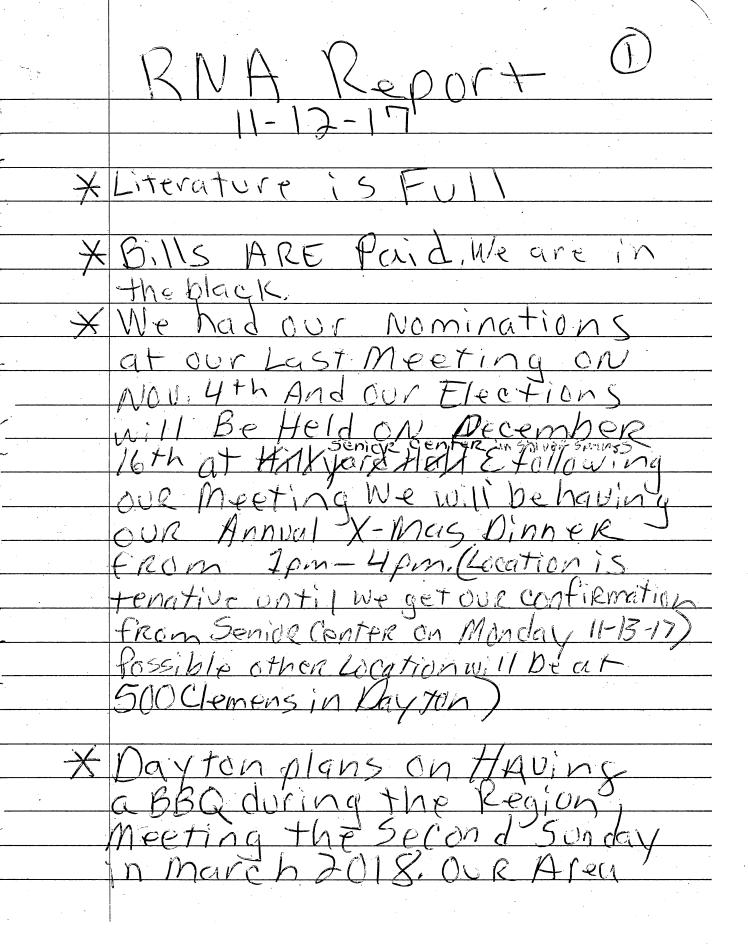
We are still waiting to hear back from officer Anderson about setting up a meeting in the local jail.
