At 10:05, James C opened the meeting with the Serenity Prayer in Carson City, NV. Minutes from November approved unanimously.

- 1. Phoneline balance is \$965.32. All areas are current and payments are being received regularly. SLT paid \$180 for the year.
- 2. Next convention meeting is February 11, 2018, at Round Table Pizza (4th and Vine) in Reno at 11:00 am. Michelle, Chair, was in attendance and reported that she had some concerns that the increase in the attendance from the close-out meeting to the election meeting was stacked to elect certain people to certain positions. Several members state that this is not unheard of and has happened in the past. She knows they have their work cut out for them, but will continue to try to unify the committee and put on another great convention
- 3. Gratitude Dinner: Karen picked up the money and is waiting for the receipts to finalize the report. There was a slight discrepancy between the written report from CANA and the money turned in (\$20.77 additional funds). Karen will hopefully have the receipts soon and will send out a report then.
- 4. Treasurer RSO general account \$38,715.15 of which \$965.32 are phoneline funds. The annual list of officers was filed with the Secretary of State (\$50), the flight for Dave B's travel to WSZF was booked (\$619.80), a Fuji Park deposit refund of \$500 and a transfer from convention account of \$23,555.49 was made. An additional \$1440 was transferred due to the incorrect report of Early Birds from the convention treasurer. There were actually only 47, not 119. The convention account is \$17,523.60 (less the \$1440). Karen is trying to keep up with their books. RSC has \$8824.14.
- 5. Curt Ad hoc on SO He looked at some rents in Carson City. Sheryl did some footwork as well. Will continue to investigate. Lots of discussion about what we need, what we want. Vince states that we are just

- in the fact-finding stage at this time, and we shouldn't expect to see anything concrete for several months. A CC member was in attendance and says that CC is interested in opening an area SO. They have a building that they are looking at, and wanted to know if they could use the regional 503(c)3. This is not possible as we cannot legally provide this information to areas.
- 6. Received text from Kymberly Laine about her home group's meeting being concerned that the convention Kick-Off dinner had been booked during the same time as her home group. After some investigation, it was discovered that the dinner was actually at the VFW, not the American Legion. Fliers to be adjusted.
- 7. James asks that Michelle Vander Stoker-Wood be accepted as a board member. She has been in attendance at the past several meetings. No questions, no opposition. Welcome, Michelle!!!
- 8. It was agreed to use the same figures as last year for literature distribution from convention profits as follows: \$1200 BLAW \$800 SLT \$700 RNA \$500 GOVA \$500 CANA \$500 NLT with an additional case of soft-bound Basic Texts for H & I and BTWSP (1 case each)
- 9. All agree to send \$5000 to NAWS at this time with further discussion about sending additional contribution in the future.
- 10. Vince addresses Michelle's concerns about convention. Suggests that convention look over their guidelines and revise if they find it necessary. They must bring any changes to RSO for approval. Offers the service of RSO if they need help. Dave feels that work needs to be done to make it clear that convention is responsible to RSO and the fellowship. The convention committee has become a joke at meetings and a lot needs to be done to help get it back on track. Lengthy discussion with many comments: i.e. accountability, making convention committee attractive, not listening to predecessors....Wants to create a new model of the convention committee.

- 1) We have 3 NA meetings in 2 facilities. Warm Springs has (1) one English which Lou Z., Rob E. an I go into on Thursday's at 6 pm. We rotate going in on Thursday so we don't get burnt out. We also had requests for Spanish literature in Warm Springs. I purchased Spanish literature; it will be taken in to the facility this next week. NNCC in Carson City has (2) meetings both are English. One is on Friday at 6pm (needs outside sponsor) and the other is on Sunday at 12:30. Charles B; Lou Z. trade off every other Sunday. We are looking for more men to step up to get cleared. I do have clearance forms for anybody interested. Please take this back to your Area's.

- 4) Sheryl texted me info from a request she has received from BTWSP. Apparently, in the Carlin facility they are having NA meetings without NA sponsors. They would like both, sponsors and literature to learn more about NA recovery. I will get a hold of these folks in Carlin. Hopefully we will get a caseworker or Chaplin to help us get the information/literature that they need.
- 5) Please step up, Regional H&I makes a difference, help us move forward with Regional H&I in our Sierra Sage Region!! I am looking forward to working with new people to carry on this awesome service. We now have 4 people cleared and at least 3 applications sent in to DOC for processing/approval. We are now developing a schedule of who is going to what facility and when. I will continue to work towards developing a closer (PR/H&I) relationship with NVDOC (Nevada Dept. of Corrections).

Behind the Walls Sponsorship Program Sierra Sage Regional Report January 14, 2018

Things are running smoothly in the BTWSP, it seems we always have good news! We received 15 Requests for New packages; We mailed 12 New packages, We had 3 NQL letters; and 22 letters exchange for Sponsors and Sponsee's. Here are our current categories of growth!

- 1. Firstly, We have now connected with Region 51 SBTW in Las Vegas. I had a phone conversation with Jason Frank, (Who I met at WSLD) he is the Vice Chair of the SBTW in Region 51 (Las Vegas,NV) and we have a phone meeting scheduled this Monday (January 15th at 11 am) to see if we can help each others groups by going over our Main lists together to make sure we don't have duplicated people working both programs. It seems we had 1 inmate working the system and she had 2 sponsors which was a Godsend because it brought our two BTW groups together to have a further sharing discussion. Although we both are helping to get California's waiting list (backlog) cleared up. We are grateful that several of our male members are working with California inmates.
- 2. We are having our very first Webinar with NAWS/World Services on Wednesday June 13th, 2018 (NAWS/and other BTWSP's picked the time) Anyone can attend. We hope you can join us! We will be setup at the outdoor umbrellas at Starbucks on S. Virginia St. (At Kietzke) Reno, so if anyone wants to join in and attend we can be together. The Discussion will be "BTWSP across the United States." which will really be a delight since I have started a "BTWSP Workbook Draft Project" and it is going slow. I am hoping to have it completed in first draft, by June; and a final draft with a timeline by December 2018.
- 3. We have made a major break through with <u>Carlin Conservation Camp</u>. Two (2) Members there have written in to me, along with their Lt Harroun. They desire to have an NA meeting come in on a permanent basis and we are hoping since 2 new potential men are signing up for clearance with H&I (Jack & Patrick) that one of them can be assigned to CCC. We have the 2 inmates on our program and we are teaching them how to get personal books. They are also asking for 12-24 Basic texts, and I have turned their request over to Hoppy via personal conversation and this report. We ask if Region can send the soft covers to the Carlin Camp please. I have printed and mailed readings and some IP's.
- 4. First Annual Postage Drive is going fairly slow. We started in November, and got \$1.00 donated; and have gone to 3 events (Gratitude Dinner, Pancake Breakfast, Teps Holiday Dinner) and retained 4 books of stamps and 3/49 cent stamps. Groups sent them in the mail to us in December from: a.) Carson City Saturday Night Men's Meeting; b) Carson Morning Fix Meeting; c) Marcia B. and Justine C donated individually. We wrote receipts for the meeting donations per their requests. We plan to be at the Valentines Day Dance in Carson, Cribbage & Cabbage in March and the Aces Unity Game in April. That will complete our 6 months; and the Second Annual Postage Drive starts again in November 2018.
- 5. Welcome to Patrick R the new BLAW H&I Vice Chair is now part of our BTWSP Team!
- 6. <u>Budget:</u> We are asking for our \$155.00 Budget amount so we can stay running smoothly. We have turned in our report and Budget Balance Sheet. Please see attached.

Hi Family,

PR/Web recently spoke at the BLAW H&I and PR Breakfast where we shared out experiences with members regarding our recent WSLD seminars and some of the things we are taking on at the Regional level.

Per the directives of this Body at last RSC, we have moved forward with several exciting new projects which are meant to further our primary purpose by carrying the message in the digital sphere to our members. A Twitter account has been created and members can sign up for announcements from our Region at @sierrasagena.org. We also have begun the process of looking in to Mozeo which is a webbased texting system. As mentioned at last RSC, we have heard of several Regions using this technology. The feedback was quite positive in that within the first year of implementation Regions saw a doubling + of members attending activities, fundraisers, and willing to step up for service commitments (reference Region 51). We will need to secure a dedicated phone number which the web technology uses as the number from which these texts are sent out. I am wondering if we couldn't use Grasshopper for this? Also would like more feedback in possible options and how to move this along. I have attached the basics from Mozeo to my report. Due to being sick I have not been able to move forward yet with this Service Body's request to begin investigating an ad-hoc committee for youth. I plan on moving forward with that hopefully this next cycle.

I have also attached an email from the Region's website host. We now understand why we are receiving so many errors when members visit various pages and why updates are becoming increasingly difficult to do. The good news – its not the webmaster. The bad news – its not the webmaster. We are being throttled as according to our Web Host – we are on a shared plan. This means we are not on our own dedicated server. Our Region has experienced tremendous growth and our site hosts hundreds of visitors per day (please see attachment for web stats). This along with our growing and interactive site has, in this trusted servant's opinion, created a large amount of traffic. Our traffic along with whomever else shares our server is causing Dreamhost to throttle the activity by delivering increasingly frequent error pages both to our visitors and to the web servant as he conducts our Region's business. There are three options – 1) leave as is and hope it doesn't become worse in time, 2) upgrade our package to a dedicated server package (also alleviating about \$80 a year that web servant pays out of pocket for site backups), or 3) move server to another provider (this will take a lot of work in research as well as transferring the site and making sure all is connected and working properly). I look for healthy discussion on this topic and will follow the direction of this body in its decision.

Several meetings have been added to our meeting list. Friday and Saturday evening in the BLAW. A Mon-Fri morning wakeup in the BLAW. And a Mon, Wed, and Fri morning wakeup in CANA. Also, SSRCNA "Early-Bird" registration has also been added to the Regional website via PayPal.
