 BLAW Public Relations is moving to change it's phonellines to a newer technology here are the details from Walter:

BLAW has made a decision to move away from Grasshopper and to utilize the information from the BMLT to generate automatic meeting info on their helpline. For other Areas that may be interested in this technology, it is possible to route your existing phone lines through YAP (consider it like a dashboard with routing functionality) and the BMLT (the database that houses all of our meeting info in the Region). Several Regions and Areas have actually reported a lower cost than their existing provider bill. Many service bodies have opted to port their existing number through "Twilio." Twilio would take place of Grasshopper or whichever phone company currently used. Initially (BLAW) would want to purchase "a phone number" from Twilio. This would be the test platform. Once all configurations and implementations are up to speck, then port the current helpline over and discontinue the Grasshopper bill...

Benefits of using YAP/BMLT over your current helpline?

- automatically updates your phoneline with meeting info from the website without needing a member manually re-recording info every time there is a meeting change.
- * voice-prompted and activated menu options
- * meeting info can then be sent to the caller via text so they have it on their phone.
- * monthly volunteers can be programmed in YAP via the web-based dashboard. Nothing else has to be done. It is day, hour, minute specific and will automatically route the calls to that person when their "shift" begins. Backups can also be put into schedule in case a primary doesn't pick up.
- * clear record of calls, duration, volunteers not picking up, etc., are all recorded in logs.
- * YAP masks the phone numbers of volunteers for their own anonymity and security.
- * large volume Areas have reported a monthly bill of about \$11-\$12 in total for their helpline. Cost is based on the activity via Twilio.
- * YAP and BMLT are free and were created by members in our Fellowship to help modernize certain parts of our service structure. Sierra Sage implemented BMLT about 3 years ago and have had nothing but good success with modernizing our meeting lists and making the info more readily available on our website.
- * This trusted servant has offered to implement YAP and configure the system based on each Areas needs.
- * Upside modern, very sleek, and cheaper alternative to existing phone lines for Areas. Downside addicts don't necessarily like change.

• Please feel free to bring this information back to your Areas. BLAW is on their way to making this change. Feel free to reach out if you need more information...



Good Morning Family,

This has been an extremely busy cycle. PR/Web is assisting the BLAW Area as they are requesting technical assistance for their transition to YAP and their new helpline system. YAP ties into Region's existing BMLT program which houses all of the Region's meeting information. Significant amounts of time have been spent researching the necessary installations and configurations.

I also attended the Western Regional Learning Days in Phoenix, AZ. It was a very good period of workshops. I attended the ones for Youth, PR, and Phonelines and also how to begin reaching the Rural Communities. One of the interesting responses to this shortage of meetings in Rural communities is to create a virtual (Zoom) meeting and place it on either the Region (for SSRNA via Outreach) or an Area's meeting list. Instructions on how to access this meeting could be put up on the website. Slides with the readings, speakers, and other aspects could be decided prior to establishing this type of meeting. There are about a half dozen Zoom meetings happening weekly around the US and even a "Virtual Area" which is in the process of being established. Some of these meetings have generated 7th Tradition support (via PayPal) which has helped to defray the technological costs.

I have also participated in the RSO/RSC Ad-Hoc on the rewrites of our guidelines for the Convention Committee. We have tentatively decided to move forward with an Annual Learning Day which will serve dual-functionality and be hosted by our Region's Public Relations. Regional Learning Day with serve both as a vehicle to transmit new information for the Western States Learning Days to the local Fellowship and also as a way to mentor new Convention trusted servants. I will be requesting a budget for both space rental and food from this body so that we can host this event. This year it is set for December 8th.



RDA Report Nov 2018

WSLD: This past month I attended the learning days that was held in Arizona. This event was attended by other members of the Sierra Sage RSC and with that said I won't be duplicating the many handouts that were picked up by the rest of the team. I will focus on the areas the Delegate team needed to be accountable for. The event was attended by all but three of the Regional Delegate Teams, that participate in the Western States Forum. I attended the workshop that described what the Zonal Forum is and what zones make up the Western Forum. There was discussion about the changes that are happening within the Forum and some the possibilities that can happen if the forum chooses to go in that direction. This event was attended by several general members as well as members that are currently RD's or RDA's.

The forum itself met as a whole over a dinner meeting, to discuss some general business that has been pending since the World Conference. At this meeting there actually was some decisions made and some actual positions voted on. The first order of business was the proposed guidelines were approved and they now will be a working document which will be used to help the Forum in the future. It is important to note that the guidelines are just a start and all the delegates agreed that they will need to be modified and adjusted as the Forum evolves.

The next order of business was to elect facilitators that will become part of the body and help keep that meetings on focus and on track. Laura from the Rio Grande Region and Dave from the San Diego/Imperial Region were nominated and elected as Facilitator and Vice Facilitator, respectively. They will now come up with an agenda that will be followed for the upcoming meeting in January, held in San Diego.

The last item that made was that funding to the Forum. The proposal was that each Region would donate \$300/ year. This will help with the funding of travel of the facilitators and to help with any other expenses that are needed. It is important to note, it was discussed and agreed that any and all money that is left unused will be directly donated to the World, at the end of year, on behalf of the entire WSZF.
