No opposition to approving minutes from September 9, 2023, with minor correction. (Minutes have been edited. If anyone would like an amended copy, please let me know)

- 5. WSLD report Arian See report Has requests which will be addressed in NB. We had a lengthy discussion about communication between all RSO members.
